## 1. INTRODUCTION

### Which entities must use this form?

The following entities must use this form:

1. Entities subject to a notification obligation laid down in Article 9 of the Act of 13 June 2005 on electronic communications (hereinafter the "ECA");
2. Entities subject to a notification obligation laid down in Article 6/1 of the Act of 26 January 2018 on postal services as well as holders of a postal licence pursuant to Article 6 of the same Act.

### This form is not applicable to the following entities:

1. Operators providing number-independent interpersonal communications services within the meaning of the ECA;
2. Postal service providers which are not holders of a postal licence and do not provide parcel delivery services in Belgium.

Operators can use this form to submit the information required by Article 13 of the Act of 26 April 2024 laying down a framework for the cybersecurity of networks and information systems of general interest for public safety.

This form must be filled in digitally. If, for signature purposes, the form is printed and scanned, the unsigned digital version and the scanned signed version shall be sent to the BIPT. The forms must be sent to [net.sec@bipt.be](mailto:net.sec@bipt.be).

The point of contact and the legal representative receive a confirmation if the registration is valid or, when appropriate, are notified that data are missing.
